



Objectives in order of priority

- 1 Provide health services to displaced people
- 2 Ensure continuity of service in all structures of the health system (adjusting for emerging needs)
- 3 Define plans for rebuilding affected structures
- 4 Rehabilitate priority affected structures
- 5 Ensure financial access to services for vulnerable groups
- 6 Strengthen governance and capacity of MSPP
- 7 Strengthen MSPP capacity to respond to disasters
- 8 Improve public hygiene and sanitation
- 9 Define public private partnership modality
- 10 Operationalize coordination cell

Projected financial requirements (\$M)




GOH Plan d'Action pour le Relevement et le Developpement d'Haiti

Summary of key priorities

- 1 Reconstruction and rehabilitation of departmental hospitals (Gonaives, Cap Haitien, Hinche, Port-de-Paix, Mirebalais, St Marc, Jacmel, Cayes, Jeremie, Miragoane)
- 2 Reconstruction and rehabilitation of reference hospitals in the metropolitan region of Port-au-Prince (HUEH, Sanatorium of Port-au-Prince, Sigueneau hospital in Leogane)
- 3 Reconstruction and rehabilitation of regional health centers (unspecified number of health centers and dispensaries in the communes, equipment and commodities for the new or refurbished facilities)
- 4 Reconstruction of public facilities in the earthquake zone (health center with beds in Bel-Air, Blood Transfusion Center in the Ouest, the labs in Eliazar Germain in Petionville, the Carrefour hospital and others)

USG Haiti Health Strategy to 2015 (1/2)

Service delivery

Strategy Snapshot

Continue to provide a “core” package of services throughout the country

Support “comprehensive” package of health services in the USG development corridors

Proposed Actions

- The “Core Package” throughout Haiti will focus on: MOH “Basic Package” of services; interventions to address gender based violence and protect orphans and vulnerable children; interventions for infectious disease (e.g., HIV, cholera)
- The “Comprehensive Package” in the USG development corridors will include: The “Core Package” plus interventions for infectious disease (e.g., lymphatic filariasis); selected expanded services (e.g., referrals for emergency obstetric care)

Impact

- Health and nutrition status of the Haitian population improved (HIV and TB prevention and care improves, infant and maternal mortality falls, reduced stunting in children)

Health System Strengthening

Invest in integrated referral networks in the corridors

Invest in 7 key areas: technical programs, health financing, health workforce, commodities and supply chain management, health information systems, governance, and performance-based contracting.

- Within Corridors: Investments in integrated communal referral networks (between rally posts, dispensaries, health centers with and without beds, communal reference hospitals and beyond to the Departmental hospital) and coordination and management support (including UCS Coordinators or other TBD by MOH)
- Outside Corridors: targeted support of Departmental backbone for provision of services / supervision
- Increase GOH management of USG service delivery funds to strengthen link between public, NGO and private service providers (at MOH centrally and at departmental level)
- At MOH centrally invest in technical programs (including lab), health financing, health workforce, commodities and supply chain management, health information systems including surveillance

- Improvements in the accessibility, quality and equity of care
- Improvements in the efficiency and sustainability of the system
- Improved Ministry of Health performance and control over health system

USG Haiti Health Strategy to 2015 (2/2)

Infra-structure

Strategy Snapshot

Build/rebuild health facilities at the communal (primary care), departmental and national level (secondary and tertiary)

Proposed Actions

- Rebuild HUEH hospital with the Governments of Haiti and France
- Improve community hospitals and dispensaries in 9-12 communal referral networks
- Improve departmental / other secondary hospitals
- Rebuild Blood Bank

Impact

- **In the corridors, major earthquake damaged health infrastructure rebuilt, and 9-12 communal referral networks functioning**

Disability

Support the establishment of disability care to support GOH and civil society to provide care and rehabilitation services for persons with disabilities

- Between 4 and 6 service centers developed or strengthened, with the ability to provide services in the areas of surgical interventions, provision of mobility aids, physical rehabilitation, psychosocial support, and vocational programs for persons with disabilities, with adequate referral services available when necessary
- Trained health staff, including 100-150 rehabilitation technicians, 20-40 prosthetists / orthotists, and 50-100 physical/occupational therapists
- Strengthened Ministries of Health and Social Affairs to ensure government organizations have the capacity to create and enforce guidelines, standards, and monitoring processes related to persons with disabilities
- Disabled People's Organizations established and working more effectively to support the rights of persons living with disabilities through advocacy and education

4 service centers, trained professionals and strengthened GOH and DPO capacity to serve and support people with disabilities

USG will work with GOH to establish a Partnership Framework

Partnership Framework will define areas GOH would like USG health systems strengthening support

USAID Forward Approach to Support GOH Health Service Delivery

GOAL: Support Haitian systems to provide primary and comprehensive health services in key geographic areas under the USG Haiti Strategy

OVERVIEW

- The new project will support the GOH to manage the delivery of health services
- The project will pursue an agreement to channel service delivery financing through the GOH
- Additional procurement mechanisms will be used to:
 - Strengthen the technical and management functions of GOH institutions and NGOs carrying out service delivery assistance
 - Monitor performance and certify payments made through partner country systems

USAID Forward Implementation and Procurement Reform

GOAL: Embrace our ability to be development entrepreneurs focused on improving how we do business—contracting with and providing grants to more and varied local partners, and creating true partnerships to create the conditions where aid is no longer necessary in the countries where we work.

OBJECTIVES

- **Strengthen partner country capacity to improve aid effectiveness and sustainability by increasing use of reliable partner country systems and institutions** to provide support to partner countries.
- Strengthen local civil society and private sector capacity to improve aid effectiveness and sustainability, by working closely with our implementing partners on **capacity building and local grant and contract allocations**
- Increase competition and broaden USAID’s partner base, by increasing the number of prime contract awards and percentage of total dollars obligated to U.S. based small and disadvantaged businesses and small NGOs (while **decreasing the number and value of large pre-competed contracts**)
- Use USG resources more efficiently and effectively, by increasing the number of fixed price contracts where feasible and appropriate, decreasing the use of “high-risk” procurement methods, and **harmonizing procurement approaches with other US government agencies working in the same substantive areas**
- **Strengthen collaboration and partnership with bilateral donors, multilateral and international organizations to increase synergies and avoid duplication.**

-**Requests for Proposals (RFPs)** are advertised on www.fedbizopps.gov to solicit offers for **contracts**

-**Requests for Application (RFAs)/Funding Opportunity Announcements** are advertised on www.grants.gov to solicit applications for **grants** – both USAID & CDC funding opportunities are posted on these sites

-**Unsolicited Proposals/Applications** to USAID are rarely funded –see http://www.usaid.gov/business/business_opportunities/

-But limited funds available for new, unique, and innovative activities
